**SUMMARY**

The master's thesis represents the final six credits and is graded through a public presentation before a panel. The final work of the master's degree is reflected in a concrete investigation on a specific topic, following a theoretical or empirical approach.

For operational purposes, it is advisable for students to begin writing their master's thesis from the moment they begin their second year.

Propose creative and innovative solutions to complex situations or problems specific to the field of knowledge, to respond to different professional and social needs.

Students should be familiar with the theoretical models from different areas of knowledge and become accustomed to working with facts and empirical data to corroborate the hypotheses derived from these models.

Students should develop a global view of the migration process, with special emphasis on the effects of the context on the migrating individual and group.



Students should understand the historical perspective and the conceptual definition of terms related to migration.

Understand the social effects of the migratory phenomenon from the dual perspective of the countries of origin and the countries of destination.

Use knowledge to produce a research report and/or a professional assessment report.

INTRODUCTION: Description of the central argument of the work. Background on the subject and current state of affairs. Preliminary work of bibliographic and documentary search. Importance, novelty and social impact of this work. Objectives and how they were achieved.

THEORETICAL FRAMEWORK: Analysis of paradigms, models and theories in which the descriptive analysis is framed.

METHOD: Research design. Preparation of the material and planning of the sample collection. In your case, inclusion of interviews and / or questionnaires. In your case, participants, interviewed sample, or description of the operation of some centers, or analysis of the social application of certain policies. Approach of working hypotheses and verification of the same.

DISCUSSION AND CONCLUSIONS: Orderly presentation of the results obtained. Analysis of the results and conclusions.

## TEACHING METHODOLOGY

The final master's work is individually tutored by its tutors.

In addition, the following may be offered: in-person theoretical and practical classes. Group work and student presentations based on small projects, problem-based learning, tutored readings, debates, text commentary, and the solution of specific case studies related to the topic. Seminars or other complementary tasks, such as project writing, may also be offered.

## EVALUATION

Note:

To submit the Master's Thesis, students must have successfully completed all subjects. The official regulations of the University of Valencia regarding the Master's Thesis will be followed.

The process to be followed for the evaluation of the Master's Thesis will consist of the presentation of the work in pdf format through the ENTREU electronic headquarters (UVEG) and its subsequent defense in a public act.

The following indicative calendar is recommended:

1. The student must contact the director of the TFM within a maximum period of two weeks from the communication of the assignment.



2. At least one month in advance of the estimated defense date, you must deliver the final draft for your final review.

3. Within the established period, the student must deposit the work through the ENTREU electronic office, in pdf format.

In his oral presentation, the student will have a maximum of 25 minutes to present orally before the court a synthesis of her TFM. She will be able to use the necessary material to support her oral presentation. Later, the court may ask the questions and comments it deems appropriate.

The court will qualify based on compliance with the competences and the rigor and quality of the TFM presented.

Assessment: The qualification obtained will be from:

1) The report presented (80%)

2) Exposure of the work (20%)

Both assessment systems can be retaken in the second sitting.

Minimum requirements: To pass the subject, both in the first and second sitting, the student must obtain a minimum grade of 5 points out of 10 in the final grade.
