Master Students will devote 4th semester to elaborate and present their Master Thesis. During 3rd semester, students need to prepare a proposal for their master thesis including a short state of the art about the topic they are interested on, formulate some research question, identify potential hypothesis to be addressed on their Master Thesis and define requirements about sampling, variables to be considered and research design. The aim of this course is to allow students to prepare such proposal under the supervision of Master staff who will guide the allocation of Master Thesis supervision and University of destination for 4th semester. At the end of second semester, after reading motivation letters of students about topic and tutor preferences, the assignment of tutors and the University where the Master Thesis will be made

The length of the research proposal depends on your agreement with your supervisor. Suggestions from the Master Consortium is s between 1,600 and 3,000 words excluding references and tables.

Content:

The exact content depends on your agreement with your supervisor. Parts that may be included in your research proposal are the following:

- a brief theoretical background of the research,
- the question(s) addressed by the research,
- a description of the research plan,
- a description of the research methods to be applied,
- a description of the techniques to be used for the processing and analyzing of data,
- a description of how ethical permission for the study will be (or has been) obtained.

TEACHING METHODOLOGY

Students will prepare their Master Thesis proposal through individual work under supervision of their tutors. Critical reading, design of research model and setting the research questions and hypotheses will be activities to be developed. Tutoring is a critical part of the course.

Thus, the nature of this course is no face-to-face, but individual autonomous work. Only tutoring and supervision sessions would be made face-to-face.

EVALUATION

First and second supervisor will read the research proposal and make a pass/fail decision.

The proposal will not get a grade. Final mark of Master Thesis proposal will be the same that for Master Thesis.
