SUMMARY

In the Master's Degree curriculum, this subject is part of itinerary II (Hispanic Literature and Theater) and itinerary III (Hispanic Studies).

This subject is oriented towards the study of issues related to the canon of contemporary Spanish and Latin American literature (20th-21st centuries), specifically its narrative and poetry. In this regard, a series of selected texts will be analyzed to explore aspects of the cultural and social debate in which they are situated (for example: critique of Modernity, fictional postulations, or literature and the market), as well as the different poetics that emerge and are questioned in that debate. The course provides specialized knowledge and fosters research interests around the development of contemporary literature, the sociocultural contexts, and the discourses involved in the configuration and transformation of the canon.

As detailed in the workload, theoretical classes are complemented with practical classes. These in-person training activities are supplemented by participation in conferences and seminars organized by the Department of Spanish Philology.



This subject takes particular account of SDG 4, and specifically contributes to "ensuring that all learners acquire the knowledge and skills necessary to promote sustainable development", which includes, among other aspects, "human rights, gender equality, promotion of a culture of peace and non-violence, citizenship and appreciation of cultural diversity".

The teaching staff of the subject participates in the Innovation Project granted by the Lifelong Learning and Educational Innovation Service of the UV: *DTD_iLAB: collaborative learning for interdisciplinary projects*.

Narrative and poetry: canonical and non-canonical texts. The concept of classic. The margins of the canon: new study approaches.

3. Literature under suspicion: the Francoist Editorial Censorship

Cultural leadership. State interventionism. Editorial censorship. Other types of censorship. Effects on the development of contemporary narrative and poetry.



4. The Literature of the Spanish Republican Exile

Exile. The Place of Exiled Literature. Dialogues between inside and outside; centre and periphery. Forms of cultural resistance (magazines, epistolaries and other self-documents).

5. The Woman Writer

Strategies of legitimation and consecration in the cultural field. The Woman of Letters in the History of Contemporary Literature: inclusions and exclusions.

These contents will be reflected in the following learning outcomes:

To identify critical and theoretical issues related to the concept of the canon.

To analyze the features that define a canonical text in the contemporary era, distinguishing them from non-canonical texts.

To interpret, using new critical approaches, both canonical and non-canonical texts in contemporary narrative and poetry.

To analyze the poetics linked to the cultural and social debate from which contemporary literary texts emerge.

TEACHING METHODOLOGY

Lectures (presentation of content based on theoretical developments) using various resources (texts, audiovisual materials, etc.).

Participatory practical classes (exercises, presentations, debates, tests, etc.), conducted individually or in groups.

Use of deductive procedures and strategies in applying acquired knowledge: problem detection and resolution, activities conducted individually or in groups (exercises, reading and critical commentary on various texts, writing assignments and/or oral presentation of results, etc.) based on prior content exposure.

Use of inductive procedures and strategies in applying acquired knowledge: problem detection and resolution, activities conducted individually or in groups (exercises, reading and critical commentary on various texts, writing assignments and/or oral presentation of results, etc.) based on basic guidelines to formulate subsequent theoretical development.

EVALUATION

Assessment of written works, essays, practical exercises, tasks, questionnaires, etc., that demonstrate the skills acquired. Non-face-to-face activity. 60%. Up to 6 points.

Assessment on the basis of final written or oral tests demonstrating the skills acquired. Non-face-to-face activity. 40%. Up to 4 points.

Non-face-to-face activities are recoverable at the second call.

Important remark: to add the grades of the evaluation system and thus pass the subject, in the activities of a non-face-to-face nature, as a whole, at least 5 points must be obtained.

Intellectual honesty is vital in academic communities, and for the fair evaluation of student work. All work submitted in this course must be original authorship. Papers that make use of fraudulent collaboration or composition with the help of artificial intelligence (ChatGPT or others) will not be accepted, except if their use is part of the course content and is authorized by the faculty teaching the course.

Both in examinations and coursework, orthographic, grammatical, and lexical accuracy will be required. Each spelling or language error will result in a reduction of the final mark, which may lead to a failing grade.
