SUMMARY

In order to protect cultural heritage, both the Spanish state and the autonomous communities have developed legal regulations (laws, decrees, etc.) to regulate its knowledge (inventories), its defence against various adverse actions or events, its knowledge through communication, and its conservation or restoration, with the aim that current and future society can enjoy this heritage. Supranational organisations, such as UNESCO or the European Union, have also generated good practice or mandatory standards that impact on the activities that cultural managers must take into account in safeguarding and enjoying cultural heritage. In class, these extensive regulations will be presented along with lectures by professionals related to the management, defence and conservation of cultural heritage, existing both in museums and in the national territory or in the social collective. This subject is a control point for the transversal competence "Critical Thinking". To do so, the student will develop activities related to the reading of scientific articles to develop their critical capacity regarding the topics discussed.
