### FELLOWHIP CALL "GRISOLIAP/2021/048 – CPI-21-240" – SUMMARY OF REQUISITES AND PROCEDURE

## General conditions of the position:

- 1) Purpose: to work on the development, validation, application and uncertainty assessment of the algorithms used by the ESR/SKYNET network to retrieve aerosol columnar properties.
- 2) Duration of the contract: it will be determined by the maximum duration of the aids that finance Santiago Grisolía Program and due to budget availability. Expected 4 years.
- 3) Gross monthly remuneration: 1,517.78 euros (12 payments per year).
- 4) Working hours: 35 hours per week.
- 5) The participants will constitute a job bank.

## General requirements of the applicants:

- 1) Applicants with different nationality than Spanish or EU may apply. It will be necessary to comply the requirements established in current regulations. Whoever gets the job, must prove the work and residence permission at the time of contract.
- 2) Have the degree that appears in the requisites. If the homologation (or equivalence) of the degree is not available at the time of the application, you must have started the homologation process at the time of the application.
- 3) To have knowledge of English and/or Spanish at a conversation level.
- 4) Not suffering from disease or being affected by physical limitation or psychic that is incompatible with the exercise of the corresponding functions.
- 5) Not be disqualified from the exercise of public functions, or not have been separated by disciplinary proceedings from any administration or public work. In the case of applicants of nationality non-Spanish, they must prove, equally not be subject to disciplinary sanction or criminal conviction that prevents, in your case, access to the public function or, if it is not available, a copy of the request for issuance, without loss of affidavit by the interested parties.

# Specific requirements of the applicants:

- 1) Possess a university degree or graduate in the area of Environment, or the equivalent in your country, issued by a University or institution <u>not belonging</u> to the European Union, and having completed said studies later as of <u>January 1, 2016</u>.
- 2) Be admitted to the Remote Sensing doctoral program at the University of Valencia (application available at <a href="https://www.uv.es/uvweb/master-remote-sensing/en/master-s-degree-remote-sensing-1285883190980.html">https://www.uv.es/uvweb/master-remote-sensing/en/master-s-degree-remote-sensing-1285883190980.html</a> or through the PI).
- 3) Possess a knowledge of Spanish or English, at the conversational level, suitable for the development of research work.
- 4) Not be in possession of the title of doctor.
- 5) Not having enjoyed a previous scholarship from the Santiago Grisolia Program.

### Preferred merits of the applicants:

- 1) Degree in Physics, Engineering, Environmental Sciences, in the area of Physics of the Atmosphere.
- 2) Master in the area of Physics of the Atmosphere and the Environment.
- 3) Programming skills: FORTRAN, C/C ++, Python, or equivalents.
- 4) Knowledge of solar radiation measurement instrumentation and atmospheric aerosols.
- 5) Knowledge of Spanish or English level B2.

- 4) The deadline for application is <u>28<sup>th</sup> June 2021</u> (included).

## **Application documents:**

- 1) Photocopy of the national identity document or the document that proves your nationality.
- 2) Photocopy of the official academic certificate including the degree and the qualifications obtained with their dates, with a Spanish translation.
- 3) Photocopy of the degree diploma (or deposit for its issuance).
- 4) Curriculum vitae, with photocopies of the documents of the merits. It is not necessary to certify the documents at the time of the application; however, the commission may later require to accredit the veracity of the documents provided.
- 5) Documentation accrediting knowledge of Spanish or of English.
